37 Motion by Commissioner Reed, seconded by Commissioner Guest, to approve December 7,
38 2020 Regular Parks and Environmental Commission Meeting Minutes as presented.

42 **VI. PRESENTATIONS.**
43

44 **A. Silverwood Updates**
45

46 Silverwood Park Supervisor Alyssa Baguss provided a power point presentation. She
47 reviewed the mission of Three Rivers Park District is to promote environmental stewardship
48 through recreation and education in a natural resources-based park system. It encompasses

1 over 27,000 acres of parks and trails and serves millions of visitors annually. An aerial view
2 of the park was provided. The park is located at County Road E and Silver Lake Blvd.
3

4 The winter programs at Silverwood Park consisted of Mid-Winter Melt, February 2, 2021
5 Ground Hogs Day Celebration; and Drawing with Mittens, February 21, 2021. In the Gallery,
6 Reconstructing the Rise of Asymmetrical Skylines by Matthew Terry will be on display
7 through April 30, 2021; as well as Circularity by Priya Thoresen.
8

9 Registration opens on March 24th at 8am for the 2021 Sumer Camps Silverwood Park from
10 June to August 2021. Reservations for 2022 opened on January 4th for weddings which will
11 continue with the COVID-19 restrictions in place. New small gatherings package includes 4
12 different spaces availability, up to 50 people, outdoors only, 4-hour rental period with reduced
13 pricing. This is available April – October. The Visitors Center is open with limited indoor
14 seating available.
15

16 The forest bathing trail has received its final, artist-designed signage and certified designation
17 (becoming the first in the state). The Natural History Trail provides the opportunity to explore
18 the 8 new self-guided stops to learn about the landscape.
19

20 Ms. Palmer asked if there would be large spaces available and Ms. Baguss stated there are the
21 amphitheater and the great hall with restrictions of 50 people or less.
22

23 Commissioner Guest asked how patronage has been in the park and Ms. Baguss stated the
24 numbers have been good.
25

26 Mr. Dale Gunderson, Kiwanis Club, noted the Kiwanis bike trail was extended to Silverwood
27 Park three years ago and asked if there is any evidence of people coming to park on their bike.
28 Ms. Baguss stated she see a number of bikers.
29

30 **B. Central Park Drain Tile Project and Stadium Field and Turf Project Update**

31
32 St. Anthony New Brighton Schools Director of Athletics Troy Urdahl reviewed a power point
33 titled Central Park Projects Update. The stadium field project has gone well. Peterson
34 Companies are the general contractors. Work was paused to allow the ground to freeze in
35 early winter which allowed for more of the soil prep work. The finish work will resume after
36 the road restrictions are lifted. The completion date is planned for August 2021. The practice
37 field should become available in the Spring of 2022. When work again begins in April – May
38 many things will happen fast and then there will be a waiting period. The drain tile project is
39 complete.
40

41 Commissioner Guest asked more about the drain tile project and Mr. Urdahl noted it was
42 installed on Fields 2 and 3.
43

44 **C. Presentation from Minneapolis Bike Advisory Committee**

1 Minneapolis Bike Advisory Committee Representative Dan Miller stated he is a friend of a
2 resident of St. Anthony (Mike Grimes). He represents Ward 1. Each Ward has a
3 representative, as well as representatives from other branches of the City. They meet three
4 times a month with one general meeting, a subcommittee meeting, and an engineering
5 meeting. There are several citizen committees including pedestrian advisory committee, senior
6 committee, disabilities committee, and others. Mr. Miller stated he lives near 22nd and
7 Stinson. Mr. Miller reviewed the projects that are underway or complete. There was a
8 sidewalk reconstruction and multi-use trail from 18th to Monroe. This summer Johnson Street
9 will be reconstructed between 18th and Johnson. There will be a multi-use trail from 18th to
10 Lowry. In 2023, Lowry Avenue is going to be reconstructed between Washington Street and
11 Johnson. In 2026, Johnson Street to the River will be done. These trails are for all ages and
12 abilities. The trails are plowed in the winter. 29th Avenue will be reconstructed in the future
13 from Central to Stinson along with 37th Avenue from Central to Stinson. Mr. Miller provided
14 an update to the Grand Rounds. The trails have been completed in sections when monies were
15 available. Commissioner Guest asked how they could help with the missing links of the
16 Grand Round. Mr. Miller stated the Minneapolis Park Board has put together a master plan
17 which included the missing link. He believes the Minneapolis Park Board and St. Anthony
18 City Staff have had some conversations. Mr. Miller referred Commissioner Guest to Carrie
19 Christensen of the Minneapolis Park Board.

20
21 Ms. Lona Doolan mentioned in 2013-2014 there was an active bike/walk group in the City.
22 She suggested St. Anthony get involved with the bike plan. Mr. Miller thought it was a good
23 idea. All bike plans funnel into the Minneapolis bike plan and safe routes to school plan.

24
25 **D. Kiwanis Update**

26
27 Mr. Dale Gunderson, Kiwanis Representative, has lived in St. Anthony since 1962. He stated
28 in 1972 the Kiwanis Club put together a St. Anthony bike route. It was aimed for the children
29 and follows streets within St. Anthony. Commissioner Reed had provided a map of the route
30 for the Commissioners. Mr. Gunderson stated it is a circle within St. Anthony. The Kiwanis
31 have since realized that no one is really using the route. One of the problems is there is no real
32 destination. It has been extended to Silverwood Park. There are no plans with what to do with
33 the route. He wanted to let the Commission know about the bike route. Ms. Anita Davis
34 stated she does use the route for the last 10-12 years.

35
36 Commissioner Guest thinks the route is wonderful and it needs to be remarked on a map along
37 with more signage or markings on the pavement.

38
39 Chair Bellinger asked how the route is communicated and Mr. Gunderson stated there are
40 maps available. He does not know how these maps should be distributed. Mr. Miller stated he
41 has taken the trail. He suggested more signage stating distance to the next point on the trail.
42 Chair Bellinger suggested the information and map be included in the City Newsletter.

43
44 Mr. Gunderson stated other destinations could be Central Park and the other parks in the City.
45

1 Ms. Doolan stated there was a suggestion to put in some type of bike pump station. Mr.
2 Gunderson stated he will bring up the suggestions at the Kiwanis meeting. The Kiwanis
3 would like to collaborate with another group either the Parks & Environmental Commission
4 or Citizens for Sustainability.

5
6 Commissioner Reed asked how the Kiwanis should get information to the Parks Commission
7 and Chair Bellinger suggested sending the items to her and she will distribute.

8
9 **E. Citizens for Sustainability Updates**

10
11 Ms. Lona Doolan, 3511 Harding Street, appeared before the Commission to provide the
12 Citizens for Sustainability update. Ms. Doolan will review CFS 2021 Priorities, organizing
13 sustainability requests and review bike/walk opportunities. The 2021 Key Priorities in St.
14 Anthony were reviewed providing Priority, Status and Support Needed. The priorities were
15 within Government, within the Community and within the Schools. Ms. Doolan reviewed the
16 support needed from the Commission and/or St. Anthony residents. Ms. Doolan continued
17 showing how the sustainability requests have been organized by Comprehensive Plan goal
18 area. She reviewed the requests in detail.

19
20 The review of bike/walk opportunities were reviewed. There is an opportunity to build on
21 37th Avenue work for building on old and new ideas to improve pedestrian safety. The CFS
22 also suggests piloting a bicycle boulevard on a City street. The improvements noted in the
23 2040 Comprehensive Plan were reviewed along with the 2014/2015 community survey results
24 Successes/Assets and Challenges. Target areas for biking and walking were identified.

25
26 Chair Bellinger asked where volunteers are needed and Ms. Doolan stated this year, they will
27 not have people come to the parks to clean-up. They would be asked to do it on their own
28 rather than congregating. Commissioner Reed stated this is not the time to encourage large
29 gatherings. There could be more creative ideas to encourage residents to help individually.

30
31 **F. Friends of the Park Update**

32
33 Ms. Lona Doolan, 3511 Harding Street, appeared before the Commission to provide the
34 Friends of the Park update. A power point presentation was given to the Commission on
35 Silver Point and Trillium Requests. Ms. Doolan reviewed a brief history, demonstration
36 gardens approved in 2019, work plans for 2021, request for expanding habitat in Silver Point,
37 request for Silver Point Gate and Pathway, request for Trillium Park Pathway and 2021 Water
38 Steward Capstone Project.

40 The history summary included:

- 42 2015 CPS raises Pollinator Pathway Idea
- 43 2016 St. Anthony Pollinator Pathway Grant
- 44 2018 Pollinator Protection Resolution

VII. COMMISSION REPORTS.

Ms. Palmer stated there has been tremendous work done by the district as the schools are reopened and students getting back to school. Any questions can be referred to the School District website.

Mr. Jeremy Gumke stated the skating rinks were open for 56 days and closed on February 28, 2021 due to warm weather conditions. The City Manager, Troy Urdahl, and he met with the contractor who is doing the reconstruction project on the tennis courts at the City Hall. The project should take one week. The courts need 30 days to cure before they are stripped. Temporary stripping will be used so the courts can be used during the cure time. Final completion is expected in June 2021. Commissioner Reed asked about pickle ball courts. Mr. Gumke stated there has been discussion and options are being considered.

Chair Bellinger stated she reviewed the history of discussions about a dog park in 2014. A Minneapolis Park Board representative presented what is considered an ideal dog park. Chair Bellinger summarized the needs for an ideal dog park. The challenge is the need for one acre designated for the dog park.
