This case was referred to the Ramsey County Attorney for the charging of a 27 year old male for felony reckless discharge of a firearm and felony ineligible person possessing a firearm; a 26 year old male with felony reckless discharge of a firearm; and a 26 year old female with felony motor vehicle theft for a vehicle that had been reported stolen in the City of Crystal.
